

RESULTS OF PHASE TWO OF THE ONLINE 2015 GROUP A PUBLIC COMMENT HEARING VOTE (Update 2/5/16)

2/5/16 Update: Prior to the OGCV going live on February 8th, an audit of the Online PCH 2 Vote tallies identified a problem with the reported results. The vote tallies did not impact the PCH 2 resulting actions or the actions placed on the OGCV. This 2/5/16 update shows the corrected vote tallies which were incorporated into the OGCV prior to the OGCV going live on February 8th.

The first step (PCH 1) in the two-step online electronic voting process to address the 2015 Group A Long Beach Public Comment Hearing electronic voting device problems concluded on January 25, 2016. The results were audited and posted January 29th. The second step (PCH 2) utilized the results from PCH 1 and an online ballot process was held January 29 – February 1, 2016. The two-step electronic process only applied to those codes impacted by the electronic voting devices. This includes all codes on the 2015 Group A Public Comment Hearing agenda except: IBC – Fire Safety code changes FS 64 through FS 179; all IBC - General code changes; and S2 -15 which was heard by the IBC – Fire Safety committee.

Based on the online actions from PCH 1, PCH 2 was conducted and the results from the 25 code changes on the ballot have been audited by ICC's third party auditor and are reported on the following pages.

PCH 2 notes:

1. PCH 2 Motion: This is the motion voted on in PCH 2. This motion is based on the results of PCH 1 and reflects the normal sequencing of motions for an in-person Public Comment Hearing. For example, the E32 – 15 online PCH 1 motion was for Disapproval. This motion failed by a total vote of 34 – 100. In accordance with Section 7.5.8.8 of CP 28, a motion for AMPC #1 is in order and was considered in PCH 2.
2. In-Person Long Beach Vote: This is the vote that was recorded at the Long Beach Public Comment Hearing and reported on the PCH 2 ballot.
3. PCH 2 Vote Total: The vote total listed in the table is the combined total of the "In-Person Long Beach Vote" which was reported on the PCH 2 ballot and the "Online PCH 2 Vote". This also includes the resulting voting percentages.

4. PCH Action to OGCV: The results of the PCH 2 vote determine the official Public Comment Hearing action for the code change. For example, code change E32 – 15 received the requisite 2/3 majority of votes for AMPC #1, and therefore the Public Comment Hearing action which will be balloted on the OGCV will be AMPC #1. On the other hand, the PCH 2 motion for AS for code change FS 26 - 15 did not receive the requisite majority of votes (2/3 required). In accordance with Section 7.5.8.9 of CP 28, the result of the Public Comment Hearing is Disapproval.

5. The required majorities for successful Public Comment Hearing action are listed in Section 7.6 of CP 28.

Along with these PCH 2 results, we will also post a comprehensive list of the results of all the code changes for the 2015 Group A Public Comment Hearing. These will be the results that determine the ballot options to be placed on the OGCV.

The OGCV is scheduled for February 8 – 21. Unlike PCH 1 and PCH 2 where the eligible voters were limited to those at the Long Beach Public Comment Hearing, all Governmental Member Voting Representatives and Honorary Members who were validated for the 2015 Group A cycle are eligible to vote.
