2021/2022 Cycle Committees

Original call deadline of June 1, 2020 extended to June 15, 2020

Volunteers are one of the most important assets of the International Code Council. Their work on the ICC Board of Directors, committees and councils is directly related to the success of ICC. It takes the time and expertise of many individuals working through the numerous ICC committees to shape the Code Council into the world-class membership organization that exists today.

This "Call for Committee" provides another opportunity to serve. Listed below are the specific Calls for Committee for the following committees:

- **2021/2022 Code Committees.** Application deadline June 15, 2020.
- **2021/2022/2023 Code Interpretation Committees.** Application deadline June 15, 2020.
- **2021/2022/2023 Code Correlation Committee.** Application deadline June 15, 2020.

2021/2022 Code Committees. International Code Committees are an instrumental part of the ICC Code Development Process. There are currently 17 Code Committees, responsible for the review and evaluation of code change proposals submitted to the 2021 International Codes. The codes will be grouped into two cycles. Group A codes will be processed in 2021. Each cycle will start with a code change submittal, utilizing ICC's online cdpACCESS submittal process, with code changes due in January of the applicable year (approximately one week following the New Years' holiday). This is followed by the posting of the code changes and then the Committee Action Hearing. The purpose of this call is to solicit applications for code committee members to preside over the Committee Action Hearings noted below.

The Committee Action Hearing schedule for the respective groups is as follows:

- Group A Code Committees considering 2021 code change proposals at the 2021 Committee Action Hearing during the period of April 11 – 21, 2021 in Rochester, NY.
- Group B Code Committees considering 2022 code change proposals at the 2022 Committee Action Hearing during the period of March 27 – April 6, 2022 in Rochester, NY.

At this time, ICC is receiving applications for Group A and Group B Code Committees. Applications will be reviewed by the Codes and Standards Council who is responsible for making recommendations to the ICC Board of Directors who make the final appointment decision. IEBC	IEBC Non structural provisions.
IgCC	Chapter 1 of the IgCC. Remainder of the code is based on the provisions of ASHRAE Standard 189.1 <i>Standard for the Design of High-Performance Green Buildings, Except Low-Rise Residential Buildings</i> .
IRC-B	IRC Building provisions. Chapters 1 – 10.
RECDC	IECC Residential energy provisions and IRC Energy provisions in Chapter 11.

2021/2022/2023 Code Interpretation Committees. The purpose of the ICC Interpretation Committees is to provide technical support for adopting jurisdictions by processing official interpretations for the International Codes. Committee Interpretations represent the official position of the International Code Council but in all cases, the final authority on matters of interpretation is the code official. There are currently 5 ICC Interpretation Committees.

Applications will be reviewed by the Codes and Standards Council who is responsible for making recommendations to the ICC Board of Directors who make the final appointment decision. 2018/2019/2020 Interpretations Committee members must reapply to be considered for re-appointment. 2021/2022/2023 Code Correlation Committee. The ICC Code Correlation Committee (CCC) is responsible for evaluating matters of consistency, coordination and format in the International Codes. This includes determining matters of maintenance responsibility (scoping) of the Code Committees, identification of editorial revisions necessary in the International Codes and correlation of technical provisions based on the actions taken at the Public Comment Hearing followed by the Online Governmental Consensus Vote. At this time, ICC is receiving applications for members. The composition of the CCC is limited to ICC Governmental Member Voting Representatives. Applications will be reviewed by the Codes and Standards Council who is responsible for making recommendations to the ICC Board of Directors who make the final appointment decision. 2018/2019/2020 Code Correlation Committee members who are ICC Governmental Member Voting Representatives must reapply to be considered for re-appointment.
