- 1.0 Purpose of Council Policy:** This policy establishes the different categories for ICC membership and outlines the benefits afforded to each category.
- 2.0 Objectives:** Through International Code Council Membership, safety professionals from around the world are able to work together in partnership with their peers in the profession. ICC’s global mission and vision are accomplished only through the engagement and support of Members.
- 3.0 ICC Membership Categories:**
 - 3.1 Public Sector Member categories:** In compliance with Article II – Membership and Article X – Code Development Process of the ICC Bylaws, Public Sector Members are those whose voting privileges extend to the Annual Business Meeting as described in CP 19, and to the Code Development Process, including Public Comment votes, as described in CP 28. These categories include:
 - 3.1.1 Governmental Members:** A governmental unit, department or agency engaged in the administration, formulation, implementation or enforcement of laws, ordinances, rules or regulations relating to the public health, safety and welfare.
 - 3.1.1.1 Governmental Member Voting Representatives:** Each Governmental Member shall exercise its votes through its designated Governmental Member Voting Representative.

- 3.2 Private Sector Membership categories:** In compliance with Article II – Membership and Article X – Code Development Process of the ICC Bylaws, Private Sector Members include “users” and “producers” as defined in ICC’s ANSI procedures and whose voting privileges include procedural actions in the ICC Code Development Process as described in CP 28.
- 3.3 Corporate Member** - An organization such as an association, society, testing laboratory, institute, company, manufacturer or corporation, interested in the purposes and objectives of the Council. Any government organization not meeting the criteria of a Governmental Member as described in Section 2.1.1 of the ICC bylaws may also join as a Corporate Member.
- 3.4 Individual Member** - An individual in one of the following categories:
- 3.4.1 Associate** - An employee of a Governmental Member who may or may not be a Governmental Member Voting Representative. (See Section 2.1.1.1 of the ICC Bylaws.)
 - 3.4.2 Building Safety Professional**- An individual who is interested in the purposes and objectives of the Council.
 - 3.4.3 Student Member** - Any individual enrolled in classes or a course of study equivalent to at least 3 credit hours of classroom instruction per week.
 - 3.4.4 Retired Member** - Any former representative of a governmental member or a corporate member or a former individual member who is retired.
 - 3.4.5 Certified Member** - Any individual who is the holder of a current certification from the International Code Council.
 - 3.4.6 Chapter Member** - A member of a state or regional chapter who has participated in a state or regional bulk purchase of memberships.
 - 3.4.7 Participating Member** – An individual who supports and participates in Council events and activities.
