

International Code Council Code Official Photo Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID OUTSIDE THE CONTINENTAL UNITED STATES AND WHERE PROHIBITED BY LAW. MUST HAVE A VALID EMAIL ADDRESS TO ENTER.

1. CONTEST PERIOD:

The International Code Council Code Official Photo Contest ("Contest") begins at 12:00 a.m. Central Standard Time ("CST") on April 17, 2017 and ends at 11:59:59 p.m. CST on May 12, 2017.

2. ELIGIBILITY:

Open only to legal U.S. residents of the 48 Continental United States and District of Columbia (void in Puerto Rico and outside the US), who are eighteen (18) years old as of the date of entry. Employees of International Code Council, and their parent, subsidiary, and affiliate companies and its advertising and promotion agencies, members of their immediate families (spouses, parents, children, and siblings and their spouses), and/or those living in the same household of any of them (whether or not related) are not eligible. Void where prohibited or restricted by law. All applicable federal, state and local laws apply.

3. HOW TO ENTER: To enter, post captioned photos on Facebook and Twitter, showing code official(s), yourself or others, performing a code official duty. The photo should show the positive impact of the work being done by the code official. Make sure to use the hashtag **#[CodeHeroes]** when posting. Photos submitted for the photo contest on Facebook and Twitter should be relevant to one or more of the following Building Safety Month weekly themes:

- Mentoring the Next Generation of Building Professionals
- Building Design Solutions for All Ages
- Manage the Damage – Preparing for Natural Disasters
- Investing in Technology for Safety, Energy & Water Efficiency

All Entries must be complete to be eligible. All Entries become the property of the International Code Council (the "Sponsor") and will not be returned. Any attempt by any entrant to submit more than one Entry by using multiple email addresses, identities, registrations, or any other methods will void that participant's Entries and that participant may be disqualified.

5. SELECTION OF WINNERS: Members of the ICC community will vote on their favorite submitted photos. Participants who submit photos of themselves and/or other persons may also vote for their own photo(s) in the gallery (active link to the gallery will be provided). The photos with the most votes will be deemed the winning photos. One winner will be selected each week of the contest.

Potential winners will be notified by email. Odds of winning depend on the number of eligible Entries received. Potential winners may be required to sign an Affidavit of Eligibility/Liability Release. Failure to return the Affidavit of Eligibility/Liability Release or respond to the notification email within five (5) business days, return of prize or prize notification as undeliverable, Sponsor's determination of ineligibility, or noncompliance with these Official Rules, will result in disqualification of the entry and, at Sponsor's discretion, an alternate winner may be selected at random from the remaining eligible entries. Alternate winner is subject to all eligibility requirements of these Official Rules.
